# III. Public Input

Jackie Lasater – Asked that South Whidbey Fire/EMS to support a change to Island County Code to add fireworks to the list of prohibited uses during a Type 1 burn ban. Commissioner Noblet clarified that the document provided is the correct wording to be used. Jackie confirmed that it was.

Mary Jane Miller – States that she is on acreage that is land locked and narrow access road and worried about fireworks and dry conditions. Address is hard to locate. Chief Walsh stated to stop by during regular business hours and SWFE can install a blue address sign. Frankie Petitclerc – Expressed concern for fireworks during any type of burn ban.

Sunny Fitzgerald – Expressed support for banning all personal fireworks during burn ban. Lee McGuire – Expressed concern for discharging of personal fireworks.

Daniel Laszlo – Expressed concern for discharging of personal fireworks.

Lenna Rose – Expressed support for banning fireworks.

Jerry Hill – Expressed concern for the discharging of personal fireworks and support the banning of fireworks.

Jim Hyde – Concerned with the climate change that we are drying out and higher risk for fires.

Linda Schwarz – Concerned with the dry conditions and the risk of a fire.

Chief Walsh stated that the South Whidbey Fire/EMS Board of Commissioners has been in support of banning the use of personal fireworks. This issue is a County wide issue.

Commissioner Noblet also shared his concerns for the discharging of personal fireworks.

Commissioner Erickson thanked everyone for their input.
