- I. Call to Order. Chairman Metz called the meeting to order at 5:30 p.m.

- III. Approval of Agenda. Commissioner Noblet made a motion to approve the agenda as presented; Commissioner Mestemacher seconded.

Commissioner Noblet made a motion to approve the Consent Agenda; Commissioner Mestemacher seconded.

- VI. Unfinished Business
 - a. Collective Bargaining Agreement Negotiations Update Chief Palmer explained that it is possible we will have two collective bargaining units as maintenance personnel cannot be in FF contract. Have had on meeting, approved 22 sections. The next Union Meeting will be next Tuesday, June 15th, to discuss economics.
 - b. Commissioner Elections Update. Chief Palmer stated that no one has filed for Commissioner Mestemacher's position with the Commissioner's officer. When there is no filing, The County will declare that candidacy void and have a special filing session. There are no provisions in state law for write-in candidates. If no one files, Commissioner Mestemacher keeps the position. He can resign then the other two will appoint a replacement.

- c. Full-Time Firefighter Hiring Update –One Lieutenant and three Firefighter/EMT's on track. Timing dependent on contract as the District can't offer the positon until we know what the salary will be. Chief Palmer stated he hopes to have it done by end of the month, the goal being to bring contract to board on July 8th. The District hopes to have all positions filled and hired by August 1st. The staff is to provide an anchor to the volunteers.
- d. Preliminary Seismic Evaluation Report 44 pages of information. Identified in 3 stations the need to do some seismic retrofit. Chief Palmer stated we won't know the depth until the sheetrock comes off the walls. This project will need to be phased into long term plan the District would like to complete least one station for the next few years.

- b. Training Room Acoustics Study Chief Palmer notified the Board that the District had an acoustic engineer come out and the study has been submitted to Carletti Architects. The estimated project would take a week to do, with an estimated cost of \$18,000 to \$20,000. Suggested some audio equipment, ADA compliant.
